

COVID-19: PARTICIPANT AGREEMENT and LIABILITY WAIVER

To be read and signed by: all athletes, coaches, members, volunteers, participants, and family members of the participants while in attendance at the VSL activities.

All Participants of the Victoria Slopitch League (the “VSL”) agree to abide by the following points when entering the VSL facilities and/ or participating in the VSL activities under the COVID-19 Response Plan and “Return To Sport” Protocols and Guidelines:

- * I agree to symptom screening checks, and will let the VSL know if I have experienced any of the symptoms in the last 14 days.
- * I agree to stay home if feeling sick, and to remain home for 14 days if experiencing COVID-19 symptoms.
- * I agree to sanitize my hands upon entering and exiting the facility, with soap or sanitizer.
- * I agree to sanitize the equipment (shared and personal equipment) I use throughout my practice or game with cleaning products approved by government and/or health authorities.
- * I agree to continue to follow social distancing protocols of staying at least 2m away from others.
- * I agree that any shared equipment used during games or practices must be sanitized before sharing.
- * I agree to abide by all of the VSL’s COVID-19 Policies and Guidelines.

- * I understand that if I do not abide by the aforementioned Policies and/ or Guidelines, it may result in the suspension of my membership temporarily.
- * I acknowledge that there are risks associated with entering the VSL facilities and/ or participating in the VSL activities, and that the measures taken by the VSL and its participants, including those set out above and under the COVID-19 Response Plan and Return to Sport Protocols, will not entirely eliminate those risks.

“I recognize the infectious nature of the COVID-19 virus, and the potential to be infected by a person showing no symptoms of exposure to the virus. I understand that there exists a risk that I could be infected with the COVID-19 virus as a result my attendance at games and practices and the Victoria Slopitch League (the "VSL") events, and suffer serious medical consequences, even death, as well as financial loss, and in full knowledge and understanding of these risks, I declare that I freely assume such risks as the consequence of my choice to use the VSL facilities and participate in the VSL activities, that such use and participation shall be entirely at my own risk, and that I, on behalf of myself, my heirs, successors and estate, hereby irrevocably waive - as against the VSL and its directors, officers, employees, sponsors, independent contractors and agents, as well as my fellow Members - all recourse, proceedings, claims, and causes of action of any kind whatsoever, in respect of any and all COVID-19 related personal injury or loss which I may suffer arising out of or connected with my attending at and using the facilities of the VSL, or others, even if such injuries or losses may have been caused solely or partly by the negligence of, or breach of duty of care by the Victoria Slopitch League.

I HAVE READ THIS LIABILITY WAIVER AND PARTICIPATION AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
